ORDINANCE NUMBER 1045

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, AMENDING ORDINANCE NUMBER 1043 TO APPOINT THE KETCHUM CITY COUNCIL AS THE BOARD OF COMMISSIONERS OF THE KETCHUM URBAN RENEWAL AGENCY; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE, PROVIDING A CODIFICATION CLAUSE; PROVIDING A REPEALER CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Idaho Code § 50-2001 et seq., the "Idaho Urban Renewal Law of 1965", the City of Ketchum adopted Resolution No. 06-033 dated April 3, 2006 making the findings necessary to empower the Ketchum Urban Renewal Agency (the "Agency"); and

WHEREAS, pursuant to Idaho Code § 50-2006, the City must establish a Board of Commissioners for the Agency to transact the business and exercise the powers established by Idaho Code § 50-2001 et seq.; and

WHEREAS, pursuant to Idaho Code § 50-2006(b)(2), the Mayor and City Council of the City of Ketchum desire to appoint themselves to such Board.

WHEREAS, on April 6, 2006, the Mayor and City Council of the City of Ketchum passed Ordinance Number 980, appointing and designating themselves as the Board of Commissioners for the Ketchum Urban Renewal Agency.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:

SECTION 1. That the Mayor and City Council of the City of Ketchum hereby re-appoint Curtis Kemp to appoint and designate themselves as the Board of Commissioners for the Ketchum Urban Renewal Agency. There shall be 5 (FIVE) Commissioners consisting of the Mayor and four City Council members. The term of office for the Agency Board shall be consistent with the term of office for Mayor and/or City Council member, respectively. Termination or resignation of a Mayor or a City Council member shall also terminate membership on the Agency Board. Appointment to a Mayor or City Council position shall also serve as an appointment on the Agency Board. The initial terms are of office are set forth below. After the initial terms of office, Commissioners shall serve for a period of 4 (FOUR) years-from the date of the appointment except that all vacancies shall be filled for the unexpired term. The initial terms of office shall be as follows:

SECTION 2. SAVINGS AND SEVERABILITY CLAUSE. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence clause, or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

<u>SECTION 3.</u> <u>CODIFICATION.</u> The City Clerk is instructed to immediately forward this ordinance to the codifier of the official municipal code for proper revision of the code.

<u>SECTION 4. REPEALER CLAUSE.</u> All City of Ketchum ordinances or resolutions or parts thereof which are in conflict herewith are hereby repealed.

<u>SECTION 5. EFFECTIVE DATE.</u> This Ordinance shall be in full force and effect from and after its passage, approval, and publication.
