ORDINANCE #1161A

(Repeal of Initiative and Referendum Procedures, Corrected)

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, REPEALING AND REPLACING ORDINANCE NO. 1161, RELATING TO THE REPEAL OF INITIATIVE AND REFERENDUM PROCEDURES, TO CORRECT CLERICAL ERRORS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR CODIFICATION; AUTHORIZING PUBLICATION BY SUMMARY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council adopted, and the Mayor executed, Ordinance No. 1161 on August 15, 2016, which Ordinance attempted to repeal Chapter 16, Title 1 of the Ketchum City Code relating to Initiative and Referendum Procedures, due to state law that became effective July 1, 2015; and

WHEREAS, Ordinance No. 1161 inadvertently (i) reversed the Title and Chapter numbers; and (ii) referred to one specific section of Title 1, Chapter 16, Ketchum City Code, for repeal instead of the entire chapter; and

WHEREAS, the Mayor and City Council deem it in the public interest to correct the clerical errors in Ordinance No. 1161 to accomplish the intended repeal of Title 1, Chapter 16, Ketchum City Code.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF KETCHUM, BLAINE COUNTY, IDAHO, as follows:

- Section 1: That Ordinance No. 1161 be, and the same is hereby repealed in its entirety.
- <u>Section 2</u>: That Chapter 16, Title 1, Ketchum City Code be, and the same is hereby repealed in its entirety.
- Section 3: Severability. If any section, subsection, clause or phrase of this Ordinance is held by a court of competent jurisdiction to be invalid, such decision shall not affect the remaining portions of this Ordinance.
- <u>Section 4</u>: <u>Repealer</u>. All previous ordinances, resolutions, orders, or parts thereof, in conflict herewith are hereby repealed, rescinded and annulled.
- <u>Section 5</u>: <u>Codification</u>. The City Clerk is hereby directed to immediately forward this Ordinance to the City's official codifier for codification.

<u>Section 6</u>: <u>Effective Date; Publication</u>. This Ordinance, or a summary thereof in compliance with Idaho Code §50-901A, shall be published once in the official newspaper of the City, and shall take effect immediately upon its passage, approval and publication.
