ORDINANCE NUMBER 851

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO AMENDING SECTION 9.08.040 (C) OF THE KETCHUM MUNICIPAL CODE, SUBSECTION 5. CONSTRUCTION OR REPAIRING OF BUILDINGS AND SUBSECTION 6. PILE DRIVERS, HAMMERS, ETC.; PROVIDING A REPEALER CLAUSE; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, THAT:

SECTION 1. That Section 9.08.040 (C) of the Ketchum Municipal Code, Subsection 5. Construction or Repairing of Buildings and Subsection 6. Pile Drivers, Hammers, Etc.; is hereby amended, altered, and changed by deleting therefrom the words lined out and adding thereto the words underlined hereinbelow, to wit:

- 5. Construction or Repairing of Buildings. The erection (including excavating) of new buildings, and demolition, and major alteration or repair of any existing building other than between the hours of eight seven-thirty a.m. and nine seven p.m. on weekdays, and between the hours of nine a.m. and six p.m. on Saturdays, except in case of urgent necessity in the interest of public health and safety. It is allowable for backhoes to operate between the hours of eight nine a.m. and nine six p.m. on Saturdays. "Major alteration or repair: is defined as having a value in excess of two thousand dollars (\$2,000.00);
- 6. Pile Drivers, Hammers, Etc. The operation of any pile driver, steam shovel, pneumatic hammer, derrick, ram or electric hoist or other appliance, blasting devices or other explosives, the use of which is attended by loud or unusual noise, other than between the hours of eight nine a.m. and nine six p.m. Monday through Friday except in case of urgent necessity in the interest of public health and safety;

<u>SECTION 2. REPEALER CLAUSE.</u> All City of Ketchum ordinances or resolutions or parts thereof which are in conflict herewith are hereby repealed.

SECTION 3. SAVINGS AND SEVERABILITY CLAUSE. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid for any reason by court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

SECTION 4. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval and publications.
